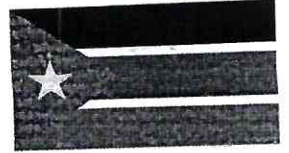

Ministerial Order No: 01/2019

Preamble and Explanatory Note:

It has been realised that the numbers of illegal immigrants in the country is in a serious increase. This mass influx of unregistered aliens, in some cases, contributes in increase of some criminal activities that affect security and the economy of the country such as counterfeiting money, and other negative activities that are against the social norms of the people of South Sudan such as engaging in prostitution.

Above all this, every sovereign state has its laws that regulate entrance of foreigners and the conditions that they must meet before entering to the country. Therefore, this exercise is a normal duty of the Government of South Sudan and shall not be misinterpreted as a move against the foreigners who are leaving in South Sudan. Rather, it is meant to regulate and legalized their existence and giving them freedom of movement and work in South Sudan.

The Order:

In exercise of the powers conferred upon me under Chapter One, Articles (7-20) of South Sudan Immigration Regulations, 2011. **I Lt. General Michael Chiangjiek Geay**, Minister of Interior, do hereby issue **Ministerial Order No: 01/2019** for Registration of all Aliens staying in the Republic of South Sudan as follows.

1. All aliens staying in the Republic of South Sudan shall be registered with the exception of the Refugees, Diplomats, and UN Mission.
2. A Committee comprised of the Directorate of Nationality, Passports, and Immigration, Interpol (NCB), National Security Service, PSU, and CID shall immediately start the registration
3. The members of the committee are strongly warned against abusing the personal and human rights of the aliens during the exercise and any act that is punishable by the law.

4. All aliens must register and comply with this order within (3) Three Months with effect from the date of this order. Failure do so, legal measures will be taken in accordance with the law.

Conditions for the Registration:

The aliens shall provide the following documents in order to be registered:

1. For those who are working in the Country, they must provide:
 - i. Valid Visa
 - ii. Working permit from the Ministry of Public Service
 - iii. Certificate of Good Conduct and Background from the CID
 - iv. And any other legal document that the Committee may deem necessary.
 - v. Medical Check for Hotel workers.
2. For those who are studying here, they must provide:
 - i. Admission letter from the School, the University, or the Institute concerned.
 - ii. Valid Passports or Travel Documents, or any other legal documents that the Committee may deem necessary.
3. Visitors and Tourists must provide:
 - i. Valid Passports or Travel Documents
 - ii. Any other legal document that the Committee may deem necessary
4. For those who are here without documents, especially Eastern African Nationals, they shall only be registered and their Embassies will be in touch with the committee
