Subject: Renewals and registration of NGOs

Following the assent on the Non-Governmental Act 2016 by the President of the Republic of South Sudan on February 10th 2016 and the appointment of a Registrar of NGOs by the Relief and Rehabilitation Commission, all NGOs/CSOs operating in South Sudan are requested to comply with the following protocols:

1. All International Organizations willing to register in South Sudan must first sign a Country Agreement with the Ministry of Humanitarian Affairs and Disaster

Management.

2. Should collect applications forms from Mr. Mac Benjamin the RRC Data Officer during

working hours.

3. Applications should be submitted to the office of Registrar of NGOs during working hours.

It is important to note that, Humanitarian Imperative comes first! Therefore, issues of humanitarian operations and coordination must be directed to the Director General for NGOs Affairs for prompt action.

Please note that, the Government of the Republic of South Sudan values your work and appreciates your commitments to the service of the vulnerable people of South Sudan.
