
Subject: Payment of PIT Withholding to the State

There have been substantial efforts made between National Government and state Government to increase the cooperation .The efforts began with the formation and convening of the Inter-Governmental Fiscal Relation (IGFR) Task Force whose recommendations were approved by the National Council of Ministers in January 2012.In subsequent joint meetings between the Minister of Finance and Economic Planning and the State Ministers of Finance, an agreement was reached on a number of issues ;including the pledged cooperation between the state and national staffs responsible for collection of revenue. Under agreement reached, a centralized collection policy was implemented under which the National Government would collect Excise taxes on behalf of the then sates. In addition, a sales tax would be established which would be shared 50/50 with the Sates .In exchange, states agreed to abandon their system of roadblocks that were adversely impacting the economic growth of South Sudan and stop collecting excise tax and the equivalent of a sales tax.

In this regard I write to inform your company/organization that the employee's personal income tax (PIT) for those recruited locally within the state is paid to the state and those recruited at national level but worked in the state their PIT withholding is paid to National Directorate of Taxation. All organized forces(Police Wildlife, fire brigade and prison warders)working in the states their PIT is Paid to central Government collected by National
