Subject: Personal Incoming Tax (PIT) Remittance to States ministries of Finance. Dear General,

This is to inform you that all organize forces and NGO local staff not foreigners, are required to remitted the personal incoming taxes (PIT) to State Ministry of Finance, as the obligation to every working citizen whether in the civil servant, Organize Forces, NGO have to do so without the failure because PIT are state revenue.

We have noted with very series concern that some states organize forces are not remitting their PIT assuming that the council of ministers resolution directing national ministry of finance to transfer organize forces money direct to their accounts but does not exempted them not to pay PIT. The breakdown of PIT payment categories according to Laws of South Sudan Taxation Act 2009, Amended 2016 are:

- 1- Staff who are receiving 600 SSP are PIT taxes free
- 2- 601-5,000 SSP is 10% PIT deduction
- 3- 5001 and above is 15% PIT deduction which 10%. Please your comply is ask accordingly.

For those who will not comply with this policy of PIT to remit them to finance will not get their salary due to that failure and NGO local staff working with State have to remit their PIT, otherwise the state government authority will ask NGO management.
