COUNTRY DIRECTORS' WEEKLY UPDATE

1. Key Takeaways.

- The 2018 HRP's ask will be USD 1.8bn targeting a population of 6.1m out of 7m in need.
- IPC is scheduled to be launched on Monday November 5. Key highlights will be shared with members in the next Weekly Update.
- New work permit fees, which have gone up, for international staff of NGOs have been released. Circular attached with this update. Effective date is November 11.
- In the week of November 5, there is planned meeting with the Under Secretary and DG for Revenues and Taxation at the Ministry of Finance. Members will be updated accordingly.
- A presentation on protection mainstreaming, protection programming and inclusion programming was made by the NRC Inclusion Expert. She is ready to provide support to organisations on centrality of protection, which is a Strategic Objective 2 of the 2018 Humanitarian Response Plan. Forum will share presentation with members once Forum receives it.

2. Bureaucratic Impediments

- New Work Permit fees have been brought to the attention of Heads of Missions, including the IGAD Embassies citizens of whom form the bulk of NGOs international expats.
- A meeting has been planned between NGO Forum and RRC and the Directorate of National Security Security (NSS) that deals with NGOs affairs to discuss NSS-related issues so that they may be addressed.
- RRC has released a list of INGOs international staff without work permit. Issues that the Forum identified with the list include the following: missing names of those without work permit, specification of incorrect duty stations, presence of external visitors on the list, and names of missionaries. Also, some members of the list have now received work permits, others have permits pending, others do not require permits (short term visitors), and others have not been submitted. Besides, RRC inappropriately published the list on Facebook. In addition, given rate of processing of work permits by the Ministry of Labour, 1 month deadline is not going

- to be sufficient. OCHA and NGO Forum will engage RRC on this particular issue this week.
- A planned meeting between the Governor of Renk and Deputy Chair of the RRC, on the one hand, and Humanitarian Country Team representatives has been planned for the week of November 5 regarding the issues that NGOs are facing in Renk. Members will be updated about this meeting accordingly on agreed next steps.

• Weekly highlight. On 3 November SPLA troops loyal to former Chief of Staff Paul Malong converged at his compound in Juba to provide protection precipitating a responsive government forces' deployment to counter this move. The result was (is) a tense security situation, especially along the Airport Road and J1 areas. UNDSS declared Juba as WHITE (no movement), before reverting to GREEN except for J1 area on 4 November morning. As at 1200 on Sunday all appeared to be quiet in Juba and the immediate situation around Malong's residence somewhat

calmer. NGOs are, however, reminded to be vigilant and report unusual activities in order to share to other members.
