NOTICE TO ALL ALIENS SEEKING WORK PERMITS

This is to inform all Clients that penalties will be applied for Work Permits based on the following conditions.

- 1. The Alien's Organization should apply for the Work Permit on behalf of the Alien before he/she enters in the Republic of the South Sudan.
- 2. After the Alien has arrived in South Sudan, he/she should fulfil the remaining part of the Work Permit process within 10 days.
- 3. For Renewal, the Alien should apply for renewal of work permit before the expiry date. Penalty will apply for any delayance.

Please comply with the Work Permit Application instructions and the above instructions to avoid the penalty.

General Instructions to Note:

- All Aliens or HRMs collecting the payment invoices are advised to pay to the Bank of South Sudan within 10 days of collecting the Invoice.
- All Aliens or HRMs collecting the Application Forms are advised to submit back the
 applications with all the requirements completed within 15, days of receiving the
 Application Forms.

Reference Financial Act 2017/2018. This is to inform you that effective 1st November, 2017 Work Permit Fees will be charged according to the following categories:

1	Consultants and Manager	4,000
2	Professionals	3,000
. 3	Technicians	2,000
4	Skilled Workers	1,000
5	Unskilled Workers	500
6	Fines	200

Outstanding payments with the old rate are to be cleared with the Central Bank and the Ministry with immediate effect, failure to do so will result in charges with the new rate.

Work permit application forms taken earlier but submitted after 31st October, 2017 will be charged with the new rates.

The period from 1st to 10th November 2017 will be for clearing all outstanding work permit applications charged with the old rate. We will be receiving new applications from the 11th of November, 2017.
