Subject: Non Issuance of Work Permits By State Authority

It has been brought to my attention that some State Authorities are engaged in issuing work permits to foreign workers and expatriates staff contrary to the resolution of Council of Ministers No. 051/2006, Ref: SG/GOSS/J/1.A.1 dated 6th March, 2006.

The Council of Ministers in their resolution had mandated the National Ministry of Labour, Public Service and Human Resource Development to be in charge of issuing work permits as this is their sole responsibility.

As per the resolution no state authority should issue any work permit to foreign workers or expatriate staff. You are all requested to abide by the resolution, copy herewith attached for easy reference.

During your Labour inspections if you encounter any alien working without a work permit issued by the National Ministry of Labour, Public Service and Human Resource Development, kindly refer them to this Ministry in order to process the work permit as required.
