Circular No.3 SSCAA/JIA/CEO/19

To: All International Humanitarian Agencies and Airlines operators' agents assessing the Air site


This circular is to provide administrative directives to those wanted to assess the air site concerning the price of vehicles stickers. Below is the list for the prices based on the agents/organization

- 1- All International Humanitarian Agencies 600 USD each vehicle for a year
- 2- International Airlines operators 300 USD per year
- 3- Airlines Handling companies 300 USD per year
- 4- Local Airlines operators 20,000SSP per year
- 5- Personal vehicles with permission 30,000SSP per year

In this regard, all international humanitarian agencies and other operators that need to assess the air site are requested to comply with this circular and apply to South Sudan Civil Aviation Authority department of aviation security (AVSEC) for vehicles registration and approval. All payments to be done in finance office after approval. The above quoted price is per each vehicle per <sup>Year</sup> month and those assessing the airport site without stickers must pay 3,000SSP for big trucks and 2,000SSP for small cars to finance office and be issue receipt before entering into the airport. This is with immediate effect from the date of the signature
