**The High-Level Taskforce on COVID-19 Pandemic**

**Thursday, 23<sup>rd</sup> April 2020**

**Juba, South Sudan**

**The High-Level Taskforce on COVID-19 Pandemic** held its 33<sup>rd</sup> Meeting on the afternoon of Thursday 23<sup>rd</sup> April 2020 under the Chairmanship of **H. E. Dr Riek Machar Teny-Dhurgon**, the First Vice President and Deputy Chairman of the **High-Level Taskforce on COVID-19** Pandemic.

**The High-Level Taskforce** was briefed on the Coronavirus (COVID-19) Situation in South Sudan, the Region and the Globe by the **Honourable Minister for Health**.

**The Honourable Minister** informed the **Taskforce** that South Sudan has confirmed its fifth case on Thursday 23<sup>rd</sup> April 2020.

**Eighty-Three (83) out of Eighty-Four tests** on samples collected from travelers on peace mission to Tonj returned negative; one test result, however, was confirmed positive. Twenty-Six (26) other tests, including, of 22 samples collected from contacts, whose quarantine time has elapsed, all returned negative. So far, all 101 enlisted contacts of the four cases confirmed early this month, have been discharged. All cases remain in isolation in good health. **South Sudan now has five (5) confirmed cases.**

**The High-Level Taskforce** was informed that a charter plane carrying equipment and supplies, including 60 ventilators, purchased by the government of the Republic of South Sudan will arrive in the country over this weekend.

**The High-Level Taskforce** welcomes the pledge by the Africa Development Bank (AfDB) of just over USD 3.9 Million to support the government's efforts to curb the spread of COVID-19 infection in the country.

**The High-Level Taskforce** resolves that South Sudanese students on government scholarships in the Federal Democratic Republic of Ethiopia, shall remain in Ethiopia as agreed earlier by the governments of the two sisterly countries.

**The High-Level Taskforce** reiterates that South Sudanese citizens, including students, must abide by the laws of their host countries.

**On Requests for Special Permission to enter or leave the country,**

**The High-Level Taskforce resolves as follows;**

- 1- **Grant** Special Permission for the Cargo Plane AN-26/TR-OAN delivering Humanitarian Assistance to land in Bentiu and Mayom (Wankei) between 23<sup>rd</sup> and 30<sup>th</sup> April 2020.
- 2- **Grant** Special Permission for Humane Aid for Community Organisation (HACO) to fly a charter plane airlifting non-food items (WASH) from Juba to Bentiu, Mayom and Juba between 22<sup>nd</sup> and 30<sup>th</sup> April 2020.
- 3- **Grant** Special Permission to private citizen Ali Achiek Akueth to travel to Khartoum on a medical mission.
- 4- **Grant** Special Permission for free movement to Five Muslim Scholars assigned for Holy Ramadan Moon Sighting from 7:30 P.M. to 11:30 PM on the night of Thursday 23<sup>rd</sup> April 2020. Law enforcement agencies are instructed to provide necessary arrangements to facilitate their movement.
- 5- **Grant** Special Permission to a private South Sudanese citizen, Mr Zachariah Tom Riruyo to travel to Juba from Tambura on a medical mission.
- 6- **Grant** Special Permission for Kush Bank to fly money cargo plane from Juba to Agok; and from Agok to Juba on 24<sup>th</sup> April 2020. Two staff of the

Bank, Mr Cleto Yuanes and Laki Denis Joseph, who are delivering and receiving the cargos to and from Agok shall be tested for COVID-19 prior to travel.

- 7- **Grant** Special Permission to private South Sudanese citizen, Mr Atagiri James Ohide to travel to Khartoum on a medical mission.
- 8- **Grant** Special Permission for China Petroleum Engineering and Construction Corporation (CPECC) to fly a Light Air Services cargo plane delivering food items from Juba to Paloch on 24<sup>th</sup> April 2020.
- 9- **Grant** Special Permission for the Sudanese Embassy Administrative Attaché, Mr Fadul Mohamed Ahmed, to travel to Juba to resume his duties. The official must be quarantined for 14 days prior to travel to South Sudan or produce a certified COVID-19 free status and must observe a 14-day-quarantine on arrival to juba prior to engaging on his official duties.
- 10- **Grant** Special Permission to German Embassy Deputy of Mission to travel to South Sudan provided that she observes a 14-day -quarantine prior to travel to South Sudan or produce a certified COVID-19 free Status on arrival, and submit to a further 14-day-quarantine period in South Sudan prior to engaging in their official duties.

- 11- **Grant** Special Permission for Mr Christopher Trott, the British Ambassador to travel to South Sudan. Mr Trott must provide a certified evidence of a COVID-19 free status and submit to a 14-day-quarantine period in South Sudan prior to his public engagements.
- 12- **Grant** Special Permission for World Food Programme to evacuate a critically ill (pre-existing medical condition) staff member from Malakal, Upper Nile State to Juba on the UN72H flight along Rumbek-Malakal-Juba-Rumbek. The Pilot and the crew must remain onboard at all times.
- 13- **Grant** Special Permission for the ICRC to transport staff to various states. The persons on the attached list must be tested for COVID-19 prior to boarding the plane.
- 14- **Grant** Special Permission to transport the remains of Mr Noi Deng Noi from Juba to Wau. Passengers accompanying the casket must be tested for COVID-19 prior to travel.
- 15- **Grant** Special Permission to transport the remains of Late Brig. Gen. Simon Akuei from Juba to Kuajok on Saturday 25<sup>th</sup> April 2020. All travelers on the Charter must be tested prior to travel.
- 16- **Grant** Special Permission to transport the remains of Late CDE Martin Majut Yak from Juba to Kuajok on Saturday 25<sup>th</sup> April 2020. All travelers on the Charter must be tested prior to travel.

- 17- **Grant** Special Permission to transport the remains of the Late Cephas Andaraga from Juba Lanyi. All passengers accompanying the casket must be tested prior to travel.
- 18- **Grant** Special Permission for Doctors with Africa (CUAMM) to fly a cargo plane operated by Mission Aviation Fellowship (MAF) to Mundri, Maridi, Mvolo, Rumbek and Yirol. Pilot and the crew must remain onboard the plane at all times.
- 19- **Grant** Special Permission for Thirteen (13) Military officers of the United Nations to travel to South Sudan aboard an Ethiopian Airline Charter Plane. The officers must observe two-weeks (14 Days) quarantine prior to travel to South Sudan or produce certified evidence of COVID-19 free status, and submit to a further 14-day-quarantine period prior to engaging in their routine duties.
- 20- **Grant** Special Permission for the repatriation of the remains of Late Emanuel Lambek Clement Yugusuk Felix from Khartoum to Juba. The accompanying family members must be quarantined for 14days prior to engaging in the community.
- 21- **Grant** Special Permission for the family members of Hon. Kornelio Mawein Dhor to be evacuated from Khartoum to Juba on Saturday 25<sup>th</sup> April 2020 aboard a Military plane. All persons must

be quarantined for 14 days in South Sudan prior to interaction with the community.

- 22- **Grant** Special Permission for the UNDP to transport cargo truck from Uganda to South Sudan as per the following details:

- 23- **Grant** UNHCR to airlift the remains of late Ms Gladys Nymai Tap KOAH from Kampala to Bentiu aboard aircraft EY-938 operated by Waypoint PLC; type DC-9. Persons accompanying casket must be quarantined for 14 days in South Sudan.

- 24- **Grant** MCC Warehouse to temporarily open for supply of construction material to the Ministry of Education and Instruction.

- 25- **Grant** Special Permission for Samaritan Purse's Mrs. Winnie Solomon to travel to Agok with cash of SSP 3,000,000 24<sup>th</sup> March 2020. Mrs Winnie Solomon must be tested for COVID-19 prior to travel.

- 26- **Grant** Special Permission for Samaritan Purse's Mr Jacob Musa to travel to Maban with cash of USD 95,021, USD 54,000on and SSP8,080,000 24<sup>th</sup> March 2020. Mr Jacob must be tested for COVID-19 prior to travel.

- 40- **Grant** Special Permission for UNHAS flight to Maban on 27<sup>th</sup> April 2020 to transport a transmitter operated by Internews.
- 41- **Grant** Special Permission for the cargo flight EY-26255 to fly to Maban on 24-27 April 2020. Each flight shall be considered on a case by case basis.
- 42- **Grant** Special Permission for ARC to transport WASH equipment to Chukudum from 24<sup>th</sup> April to 24<sup>th</sup> May 2020 on truck number SSD 441 P. The vehicle must not carry passengers. The Driver and the Assistant must be tested prior to travel.
- 43- **Grant** Special Permission for the Goal to transport assorted goods by river. The Accompanying staff must be tested for COVID-19 prior to travel.
- 44- **Grant** Special Permission for the Lobal Aim South Sudan to transport agricultural inputs by road to Magwei and Torit on 24-30 April 2020, on the Vehicle bearing registration number KBG63L/ZE3371.


