**THE REPUBLIC OF SOUTH SUDAN (RSS):**

Republican Order No.13/2020 for the **Reconstitution and Appointment of Members of National Taskforce Committee on Coronavirus Disease (COVID-19)**, 2020 A.D.

1. **TITLE AND COMMENCEMENT:**

This Order shall be cited as "The Republican Order No.13/2020 for the **Reconstitution and Appointment of Members of National Taskforce Committee on Coronavirus Disease (COVID-19)**, 2020 A.D." and shall come into force on the date of its signature by the President of the Republic.

2. **THE ORDER:**

In exercise of the powers conferred upon me under Article 106A(2)(c) of the Transitional Constitution of the Republic of South Sudan, 2011 (as amended), I, Salva Kiir Mayardit, President of the Republic of South Sudan, do hereby issue this Republican Order for the **Reconstitution and Appointment of Members of National Taskforce Committee on**

**Coronavirus Disease (COVID-19)** with effect from 18<sup>th</sup> May 2020 as hereunder:

### **3. TERMS OF REFERENCE FOR THE COMMITTEE**

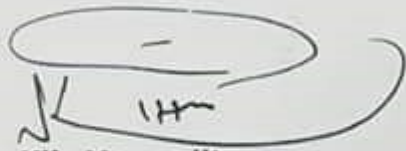
- (1) The National Taskforce Committee on Coronavirus Disease (COVID-19) hereinafter referred to as ("the National Taskforce") shall adopt the previous work of the High-Level Taskforce Committee on COVID-19 accordingly.
- (2) The National Taskforce shall conduct regular and accurate random and voluntary testing to establish the magnitude of infections and advice the Country based on the recommendations of the World Health Organization and the Ministry of Health accordingly.
- (3) The National Taskforce shall assess the established quarantine and isolation Centers or Facilities and ensure that they are fully equipped with testing kits, ventilators, necessary medicines and medical personnel.
- (4) The National Taskforce shall ensure that any person or persons suspected with COVID-19 must be immediately placed on Institutional or self Quarantine and keenly monitored to avoid rampant spread of the Disease. And for those confirmed with COVID-19, must be immediately put on treatment in Isolation Centres accordingly.
- (5) The National Taskforce shall in coordination and collaboration with all the relevant Health Bodies such as the World Health



Organization (WHO), the African Union Centre for Disease Control and Prevention (Africa CDC), as well as Non-Governmental Organizations operating in the Country, including Development Partners, Security Organs, Civil Society Organizations, Women and Youth Groups, to ensure that all the citizens are informed about the dangers of COVID-19 and educate them on the preventive and precautionary measures taken thereof.

- (6) The National Taskforce may form sub-committees of not more than ten (10) Members at the Ten (10) States and the three (3) Administrative Areas of the Republic of South Sudan in order to implement the directives of the National Taskforce Committee at the level of the States, Counties, Payams and Bomas respectively.
- (7) The Minister of Finance and Planning is hereby directed to avail the necessary funds for the Committee to implement its task.
- (8) The National Taskforce may Co-opt not more than three (3) additional Members who shall mainly be Technocrats from the medical profession, where it deems necessary and appropriate.
- (9) The Taskforce shall report to the Presidency periodically.
