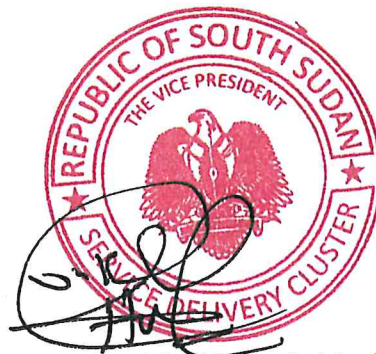

- 2- **Grant** special permission of clearance to **DCA** to transport essential items by road from Juba to Kajo-keji, South Sudan. The truck driver must be Covid-19 free.
- 3- **Grant** special permission of clearance for **PSI** to transport essential NFI items by road from Juba to Lakes State and Warrap State, South Sudan. The truck drivers must be Covid-19 free.
- 4- **Grant** special permission of clearance for **CM MB** to transport essential items by river from Juba to Yida, South Sudan. Staffs must be Covid-19 free.
