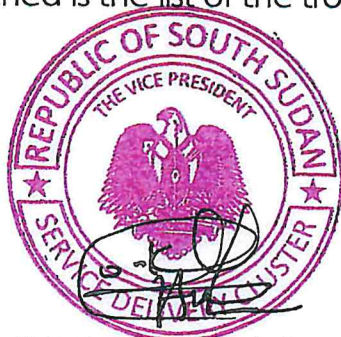
Request for special permission to leave, enter or travel within South Sudan.

- 3- **Grant** special permission to **Japanese Amb. H. E Noahiro TSUTSUMI** from Japan to Juba, South Sudan. He must be quarantined for 14 days on arrival.
- 4- **Grant** special permission to **SC** staff Mr. Khan Muhamemd Taimoor from Pakistan to Juba, South Sudan. He must be quarantined for 14 days on arrival.
