Sub; Remittance of the personal income tax (PIT) of the category of employees under Jonglei state

In reference to the letter dated 8th Jan-2021(attached) from the office of H.E the Governor of Jonglei state and subsequent RRC meeting with officials in the office of the Governor regarding the remittance of personal income tax (PIT) of the NGOs and Companies employees operating in Jonglei State. The meeting resolved that RRC should further inform the NGOs and companies on the details implementation of the Governor's directives.

Therefore, the RRC Jonglei state is hereby requesting all the NGOs and companies to take note of the following;

1. The Jonglei state USD Account No;**6940033413; ECO BANK** is the only authorized account for remittance of NGOs and Companies personal income tax (PIT)
2. The previous PIT payment arrangement under the 32 states cease to exist with immediate effect hence, the PIT that used to be remitted to the defunct States of Jonglei, Bieh, Fangak and Akobo is directed to be paid to the above mentioned account.
3. The NGOs and companies shall be submitting their PIT deposit slip to either Jonglei state coordination office in Juba, State Ministry of Finance in Bor and RRC state office in Bor. The aim of deposit slip submission is to confirm that the individual NGO and company has Paid their PIT to the state Government.
4. The NGOs and companies operating in Jonglei State are requested to submit their last year PIT deposite slips for the defunct States of Jonglei, Bieh, Fangak and Akobo as from February to December 2020 to Jonglei State coordination office in Juba..

The purpose of the above cited arrangement is to harmonize the PIT payment as part of the administrative transition from 32 states to ten (10) states. Therefore, I am requesting all the NGOs and companies operating in Jonglei state to adapt the Governor's directives with immediate effect.
