RE: REVOKE OF RoSS LETTER

Reference is made to the non-dated letter from the RoSS Deputy Director of defunct Phow State. The contents of the letter are as follows:

- 1. Ordering the national staff of non-governmental Organisations to pay monthly 10% of their salary as local contribution or tax to Local Government.**
- 2. Demanding an amount of \$300 for all NGOs hiring a charter flight at every airstrip in Fangak County.**

Reference is further made to the past instructions from the SPLM/A-IO leadership which stopped such demand of airport fee and also banning non-legally defined taxes. The letter has negative impact on the humanitarian service delivery to the people of Fangak County in this critical time of floods. This time demands more partnership and cooperation to alleviate suffering. On the above basis, *the letter of RoSS is revoked until further notice*. All humanitarian chartered flights are encouraged to land and work freely in Fangak County. The people of Fangak and their government shall continue to work in harmony with NGO staff and humanitarian agencies to timely deliver needed services.

Any RoSS staff in Fangak County is hereby advised to take decisions prior to the consultation and approval of the County Commissioner. For any further advice, please keep in touch with the Office of the County Commissioner.

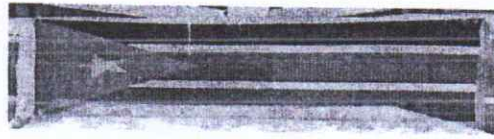
