**Subject: Fees Charged on Services Provided by the Ministry of Labour**



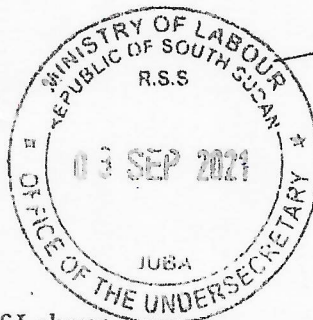
1. Issuance of Labour card: SSP 500

You are hereby requested to adhere to the above without fail.


