Subject: Issues of Labour Administration in Upper Nile State

The National Ministry of Labour takes this opportunity to present it compliments to your esteemed office and would like to draw your attention to some issues related to the Ministry of Labour in Upper Nile State.

It has been brought to my attention that the following is happening in Upper Nile State Labour Office:

- 1. Deduction of 10% from the terminal benefits of workers whose contract has ended.
- 2. Registration of NGOs staff travelling to the field and payment of a sum of \$9 nine dollars as registration charges at the airport.
- 3. Various charges for services delivered to the NGOs by the Labour office.
- 4. Registration of NGOs at the State level charging (USD 1,500).

These issues have been raised to my office by the NGOs Forum and other organizations. All charges that are made are backed up by the law, there is no law giving the Ministry of Labour at the state level to deduct 10% of workers terminal benefits nor registration of workers going for a mission to the state offices.

The only instance for the ministry to get some fees is when issuing the Labour card to National job seekers and when reviewing job advertisements. (Circular No. 01/2021) attached, all other services are rendered free of charge.

All NGOs are registered by South Sudan Relief and Rehabilitation Commission at the level of the National Government. The Ministry of Labour has no mandate to carry out registration of NGOs. I am drawing this to your attention for review as the list of fees is decided by the cabinet.

1. Issuance of Labour card:

SSP 500

2. Clearance of Advertisement:

SSP 1,000

Please note that the Labour card is to be issues to job seekers who have completed their studies and are ready to join the Labour Market. Job advertisement presented by the NGOs or companies for clearance the fee is levied for the advertisement not the number of people needed in the Job Advertisement.

You are hereby requested to adhere to the above without fail.
